WHEREFORE, Complainant prays that the Commissioner of Agriculture take the following actions, singularly or in any combination: (1) call and hold a hearing for the purposes of investigating this complaint in the manner provided by law; and if the Commissioner and/or the Produce Recovery Fund Board determine that the claim of Complainant against Respondent be wholly or partially due and owing and Respondent shall refuse to pay same, that the Commissioner enter an order that such claim shall be satisfied from the Produce Recovery Fund, within the limits prescribed by law, in the amount that such claim is found to be due and owing: (2) suspend or revoke the license or licenses of Respondent; (3) pursue such remedies against Respondent as may be warranted by actions of Respondent; and (4) make such other orders or decrees permitted by law and the Act. NOTE: A filing fee of \$50.00 must be submitted with this complaint before the complaint will be accepted for filing. The filing of a false or malicious claim under the Handling and Marketing of Perishable Commodities Act is punishable by a fine of \$2,000 and/or confinement in jail for a period not to exceed 180 days.
