Notice of intent to cancel shall be sent to: Texas Department of Agriculture, Attn: Coordinator for Grain Warehouse Programs, P.O. Box 12847, Austin, Texas 78711. A principal may cancel a bond only upon written approval by the department of a substitute bond. Liability under the bond shall cease to accrue on the effective date of cancellation. Notwithstanding such cancellation, the department or any other interested party, as established by Chapter 14, may collect under the bond for any claim that arose in the period during which the bond was in effect, provided that the claim is filed within the applicable limitations period established by Chapter 14.

The provisions of Chapter 14, relating to bonding, are hereby made applicable to this instrument and the parties hereto and are incorporated herein by reference. In the event of any conflict, the provisions of Chapter 14 and the rules promulgated thereunder shall control over the provisions of this bond.

This document becomes public record and is subject to disclosure. With few exceptions, you have the right to request and be informed about the information that the State of Texas collects about you. You are entitled to receive and review the information upon request. You also have the right to ask the state agency to correct any information that is determined to be incorrect.
