

Texas Department of Agriculture Metrology Program Standard Calibration Services and Fee Schedule

This document outlines the standard offer and conditions under which the lab will provide calibration services to customers.

- The fees listed are authorized by Texas Agriculture Code §13.115 and set by Texas Administrative Code 4 TAC §12.30.
- The standard operating procedures (SOP) listed below will be used unless alternative procedures are agreed upon in advance.
- Unless specifically authorized, the lab will conduct only the services within the lab's scope of recognition, as certified by NIST.
- Customers must satisfactorily complete and submit TDA form RMT-001 to request calibration services.
- Customers must comply with handbook specifications and the conditions of the lab's mass and volume requirements letters.

MASS:

Tolerance Calibration: NIST Class F, ASTM Class 5, ASTM Class 6 (See NIST Handbook 44, 105-1 & 105-8)
