This will reduce the burden on the producers and provide more aquaculture products at reasonable prices to the citizens of Texas.

<p>The 2009 Aquaculture Grant Program is designed to assist aquaculture producers for losses associated with high feed costs during the 2008 calendar year. Producers were eligible to receive assistance in the amount of their 2008 average feed prices less the states 2003-2007 5 year average feed price, multiplied by the producers total feed deliveries in calendar year 2008. Texas producers were qualified for a total of \$3,745,806.01. The total award granted to Texas was \$1,732,244.00. The reduced funding required all grants to be proportionately reduced. Assistance was provided to producers in the form of feed credits, which may only be applied to future feed purchases. During this quarter, payments to vendors were made based on the established formula and limits established. TDA was administering this program on a feed credit system as stated in the project information section. Upon approval from USDA for TDA to reallocate unspent funds this past September, 2010, TDA discovered that several of the feed mills had gone out of business. Feed credits to these feed mills would not benefit the producers, as the program was designed. TDA determined that the best course of action would be to reimburse individuals for feed purchased (ONLY) that had not already been paid for with Program feed credits. Feed had to have been purchased within the grant period ending September 30, 2010.</p>
