Pink Bollworm Eradication Program

The following requirements apply only in the Texas counties of Brewster, Crane, Crockett, Culberson, El Paso, Hudspeth, Jeff Davis, Loving, Pecos, Presidio, Reeves, Terrell, Val Verde, Ward, and Winkler participating in a sanctioned program for the active eradication of pink bollworm where sterile PBW moth technology (SIT) is an integral component and for a subsequent 3-year confirmation phase. An individual grower may plant up to 100% Bollgard 3 cotton. Sterile moth releases will be made as needed in both *Bt* and *non-Bt* cotton and in accordance with the criteria established in the Minimum Standards for Pink Bollworm Post Eradication document as approved by USDA/APHIS and the National Cotton Council Pink Bollworm Action Committee.
