TDA is pleased to announce the release of two new grant opportunities for the upcoming Program Year 2025:

2025 Community Development Fund (CDV)

Purpose: The Community Development Fund is the largest fund category in the TxCDBG program. This fund is

available on a biennial basis for funding through a competition in each of the 24 state planning regions. Although most funds are used for public facilities (water/wastewater infrastructure, street and drainage improvements and housing activities), there are numerous other activities for which

these funds may be used.

Maximum Grant Amount: \$750,000

Community Application Deadline: December 9, 2024 Link to CDV landing page, including the Application Guide

2025 Colonia Fund Construction Program (CFC)

Purpose: The Colonia Fund - Construction program provides eligible applicants with grants to fund water and wastewater improvements, housing rehabilitation for low- to moderate-income households, and similar basic needs for colonia residents.

The term "colonia" means any identifiable unincorporated community that is determined to be a colonia on the basis of objective criteria, including lack of potable water supply, lack of adequate sewage systems, and lack of decent, safe, and sanitary housing; and was in existence as a colonia before the date of the enactment of the Cranston-Gonzalez National Affordable Housing Act (November 28, 1990). The colonia must be located with 150 miles of the Texas-Mexico border to be eligible for CFC funding.

Maximum Grant Amount: \$1,000,000

Community Application Deadline: December 9, 2024

Application Webinars and Technical Assistance

The application process for 2025 has been revised to include two distinct phases. The Community Application, due December 9, 2024, will collect information needed to assess community eligibility and scoring. Applicants that score within funding range will be invited to submit a Project Application that identifies a project and details the specific work to be performed.
