TDA is pleased to introduce a new feature in TDA-GO. Individuals with a "Consultant" role will now be able to access a Reports tab to obtain information on all relevant documents in TDA-GO, across multiple Grant Recipients.

- OCSAR Report Status – assist in determining whether a particular Grant Recipient was required to complete an OCSAR, and the status of the document.
- Organization Documents (Group A) – assist in determining whether a particular Grant Recipient has uploaded documents to the Organization Profile, including Civil Rights policies and similar documents that are not grant-specific. (Any numerical value indicates the upload is present – the file number reported is not relevant for this report)
- Grant Assignments and Dates – provides the award, start, end and closeout dates for each grant; this report may be filtered using the TDA staff or Administrator point of contact names entered on the Grant Overview page.

Note: these reports are not limited to documents to which the individual has been assigned or grant recipients with which the individual has a contractual relationship. The limited information available in these reports is intended to assist in summarizing grant status and community-wide requirements across the TxCDBG program. Additional reports may be added in the future.

- The MSR Main Page has been updated to visually distinguish between the different phases of contracting information. Please remember to complete each section as soon as the information is known, rather than waiting to enter all information at once. The MSR is an important method of communicating the progress of the project to TDA staff. In addition, several new fields have been added to provide additional information about the contract / service being provided.
- The Project Completion Report – Direct Beneficiaries page has been updated to require household information needed for HUD reporting.
