The Texas Department of Housing and Community Affairs (TDHCA) announces the release of the draft 2024 State of Texas Analysis of Impediments to Fair Housing Choice (AI) and Notice of Public Hearings and Public Comment Period for the draft AI.

The Analysis of Impediments to Fair Housing Choice is a planning document that guides the state's affordable housing strategy for the next five years. This process is required of recipients of U.S. Department of Housing and Urban Development (HUD) Community Planning and Development (CPD) grant funds as part of their obligation to undertake to affirmatively further fair housing (AFFH) under the Fair Housing Act. TDHCA is the agency in Texas that is primarily responsible for creating the Al. The Plan may be accessed from TDHCA's Public Comment web page at https://www.tdhca.texas.gov/tdhca-public-comment-center.

The public comment period for the AI will be open from Wednesday, April 3, 2024, through Friday, May 3, 2024. In addition, written comments concerning the AI may be submitted in the following ways:

TDHCA will hold four public hearings during the 31-day Public Comment period to accept public comment on the draft 2024 AI.
