RESOLUTION

A RESOLUTION OF THE (COMMISSIONERS COURT OF XYZ COUNTY/CITY COUNCIL OF XYZ) , TEXAS, AUTHORIZING THE SUBMISSION OF A MULTI-JURISDICTIONAL TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF AGRICULTURE FOR THE FIRE, AMBULANCE AND SERVICE TRUCK FUND; AND AUTHORIZING THE (COUNTY JUDGE/MAYOR) TO ACT AS THE (COUNTY'S/CITY'S) EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE (COUNTY'S/CITY'S) PARTICIPATION IN THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the (Commissioners Court of XYZ County/City Council of XYZ) desires to develop a viable community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low-to-moderate income; and

WHEREAS, certain conditions exist which represent a threat to the public health and safety; and

WHEREAS, it is necessary and in the best interests of (XYZ County/City of XYZ) to apply for funding under the Texas Community Development Block Grant Program;

NOW, THEREFORE, BE IT RESOLVED BY THE (COMMISSIONER'S COURT OF XYZ COUNTY/CITY COUNCIL OF XYZ), TEXAS:

1. That a multi-jurisdictional Texas Community Development Block Grant Program application in conjunction with (Lead applicant XYZ) for the Fire, Ambulance and Service Truck Fund is hereby authorized to be filed on behalf of the (Co- applicant XYZ) with the Texas Department of Agriculture.
2. That the (County's/City's) application be placed in competition for funding under the Fire, Ambulance and Service Truck Fund.
3. That the application be for (up to \$500,000.00) of grant funds to provide (first-time fire truck).
4. That the (Lead applicant XYZ) be the authorized lead applicant.
5. That the (Commissioners Court/City Council) directs and designates the (County Judge/Mayor) as the (County's/City's) Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the (County's/City's) participation in the Texas Community Development Block Grant Program.
6. That all funds will be used in accordance with all applicable federal, state, local and programmatic requirements including but not limited to procurement, environmental review, labor standards, real property acquisition, and civil rights requirements.
7. That it further be stated that (XYZ County/City of XYZ) is committing (\$5,000.00) from its (General Fund) as a cash contribution toward the (administration activities) of this (first-time fire truck) project.
