The Deep East Texas Regional Review Committee (DETRRC) Guidebook has been prepared in accordance with the 2012 TxCDBG Action Plan and the 2013-2014 Regional Review Committee Scoring and Training Guidelines for the Community Development Fund. The Guidebook provides eligible applicants from the Deep East Texas Council of Governments (DETCOG) region with the application guidelines necessary to be scored under the DETRRC scoring criteria.

PART II – DETRRC Approved Actions

1. The DETRRC held its required Public Hearing on April 19, 2012 to hear Public comments on the proposed objective scoring criteria, and to approve the RRC Guidebook , project priorities and the objective scoring criteria.
2. The DETRRC selected the Deep East Texas Council of Governments as support staff to develop and disseminate the RRC Guidebook and calculate the RRC scores and provide other administrative RRC support.
3. The RRC established First Priority Projects as All Eligible TxCDBG project activities, with the exception of excluding Affordable New Housing, or Homeownership Assistance, or Public Housing Modernization activities.
4. The RRC established the maximum grant amounts for the region:
 - Single Jurisdiction: \$275,000.00
 - Multi-Jurisdictions: \$350,000.00
5. The RRC did not establish set-asides for housing and non-border colonia projects.

PART III – DETRRC Summary of Objective Scoring Criteria

Total points by DETRRC: **50 points**

1. Project Type: **Total Points 50**
 - First Priority – **50 points**

PART IV – DETRRC Objective Scoring Criteria

Project Type/Priority – 50 Total Points

Scoring Factor:

1. Is the project categorized as a First Priority project, which includes all eligible TxCDBG Project Activities except for Affordable New Housing, Homeownership assistance, or Public Housing Modernization activities which are considered ineligible activities ? **(50 points maximum)**

METHODOLOGY: CD application Table 1 and Table 2 will be reviewed to determine the appropriate project type category and points will be assigned.

Although all eligible activities are considered under the first Priority(Note:Ineligible Activities are Affordable New Housing,Homeownership Assistance, and Public Housing Modernization) , TDA will review all activities to determine eligibility and compliance with a national objective. The RRC support staff will only receive a verified CD application Table 1 and Table 2 with correct information for scoring purposes.

TDA may require additional information from applicants outside of information requested by the RRC or in the CD Fund application for various types of eligible activities to determine eligibility and compliance with a national objective and other program requirements. This determination will be made by TDA upon review of the applications submitted for funding under the 2013-2014 Community Development Fund application cycle.
