### Family Land Heritage Applications Due May 1

Commissioner Miller is proud to invite Texas farmers and ranchers to apply for TDA's Family Land Heritage (FLH) program, which pays tribute to families who have kept their land in continuous agricultural production for at least 100 years. As TDA continues this proud tradition of honoring true Lone Star pioneers, Texas families are asked to submit their applications for recognition in the 2018 FLH registry by **Tuesday, May 1**.

Eligible farms and ranches must be owned and operated by the descendants of the founder, either through blood, marriage or adoption. At least 10 acres of the land must have been in continuous agricultural production for the past 100 years or more.

This fall, Commissioner Miller will honor farms and ranches established in 1918 or earlier at the FLH ceremony at the Texas Capitol.



"As a longtime rancher myself, I am proud to pay tribute to the men and women who nurture our land, and I encourage future generations to keep the legacy going," Commissioner Miller said.

### **Commissioner Miller Calls For Action on Temporary Worker Program**

In a letter addressed to federal officials, Commissioner Miller asked for an opening of the program that affects the availability of temporary workers like those needed by the Texas shrimp and other agriculture industries.

"As Commissioner of Agriculture for the state of Texas, I am encouraging the Trump Administration to take immediate action and open the petition process under the H-2B Nonimmigrant Temporary Worker Program," Commissioner Miller said. "This is critical for our agricultural economy, as well as the small and seasonal businesses that rely on the temporary workers provided through the H-2B program in Texas."

The letter from Commissioner Miller simply requests that the federal agencies implement the number of temporary worker visas already approved by Congress — not an expansion of the program.

## **TDA to Hold Statewide Meetings to Discuss Produce Safety Rule**

We're pleased to announce that TDA will hold a series of community meetings across the state to collect input on implementing the new federal law to promote the safety of fruits and vegetables grown across the country. The meetings will serve as a forum to gather public input as TDA develops the rules to administer this comprehensive new federal mandate.

The Food Safety Modernization Act (FSMA), specifically the Produce Rule, establishes science-based minimum standards for the safe growing, harvesting, packing and holding of fruits and vegetables grown for human consumption. This is the first time such standards have been implemented. That's why TDA is hosting these meetings across the state — we want to give producers an opportunity to discuss the development of the administrative rules as they pertain to farm verification, inspection and enforcement.
