Additionally, the U.S. Department of Agriculture (USDA) has a variety of resources available to help producers who have suffered livestock losses as a result of this storm. It's critical to contact your local USDA Farm Services Agency office to apply as soon as you identify a livestock loss, as there may be a deadline to apply for some types of assistance. Giving Agriculture a Voice in Washington, D.C.



TDA is working hard to give Texas agricultural producers a voice in venues across the country and around the world. In fact, last month, Commissioner Miller traveled to Washington, D.C., to spread the word that *Texas agriculture matters* on Capitol Hill. Commissioner Miller met with lawmakers and federal officials and fought for the issues that Texas ag producers care about.

One topic of discussion was the impact of federal overreach on agricultural operations. Commissioner Miller addressed two items in particular — the Environmental Protection Agency's heavy-handed Waters of the U.S. (WOTUS) rule and the Bureau of Land Management's attempted land-grab near the Red River. Both of these threaten private property rights and our agriculture industry, and Commissioner Miller is working hard to ensure our farmers, ranchers and property owners are protected.

Additionally, Commissioner Miller highlighted the issues Texas shrimpers are facing. There has been a flood of imported, farm-raised shrimp entering the U.S. market. Much of this imported shrimp is raised in less-than-ideal circumstances. Then, when this shrimp arrives in the U.S., only two percent is inspected by the Food and Drug Administration. Commissioner Miller is hopeful that his meetings in D.C. will help begin the process of leveling the playing field for local shrimpers, so everyone can have access to healthy, quality Gulf shrimp, as well as protect this important segment of Texas' agriculture industry.

TDA Awards \$1.8 Million to Improve Production of Fruits, Vegetables And Specialty Crops



In December, Commissioner Miller announced TDA awarded more than \$1.8 million in federal funding to <u>15</u> <u>specialty crop projects</u> across the state. Administered by USDA's Agricultural Marketing Service, the Specialty Crop Block Grant Program helps enhance markets for specialty crops like fruits, vegetables, tree nuts, dried fruits and nursery crops. These grants also help promote the horticulture and floriculture industries.

"Texas is a leader in the production of many specialty crops, including citrus, onions, watermelons, pecans and grapes," Commissioner Miller said. "This round of

specialty crop funding will support these growing segments of the Texas agriculture industry and producers across the state through research and promotional activities. The more support we give our Texas farmers, the more we can enjoy locally grown, fresh products."

Networking Works for Agriculture and Young Texans

TDA's innovative new Farm Fresh Network offers a simple way for Texas farmers, ranchers and distributors to connect their agricultural products with the schools and child care centers in their communities. Agricultural producers can simply go <u>online</u> and enter their product and contact information, and the Texas Farm Fresh Network does the rest.

Schools and child care centers can access producer information when looking for specific products in their area. Texas child nutrition programs represent a vast market that already accounts for millions of dollars spent on locally produced grains, proteins, fruits, vegetables and dairy. At TDA, we're working to grow this connection because wholesome, locally grown food helps nourish both growing Texans and our growing economy.

Applications for Plant Seed Board Due Jan. 30

TDA is currently accepting applications to fill a seat on the Texas Seed and Plant Board. The six-member board prescribes rules and procedures by which seed and plant certification is conducted in Texas and serves as the mechanism for proposing new seed varieties for Texas growers. Additionally, the board reviews and approves foundation, registered and certified seed growers, and approves TDA inspectors to perform duties under the seed certification program.

A member who sells Texas foundation, registered or certified seeds or plants is needed to fill the vacancy and complete the six-member board. Click <u>here</u> to download an application.

Weigh Stations Weigh More Than Just Trucks

In an effort to enhance biosecurity and consumer protection, TDA monitors agriculture plant products entering the state through a critical entry point inspection program. Road station inspections serve as a vital tool in conducting guarantine enforcement. Using weigh station sites in cooperation with the Texas Department of Public Safety, TDA inspectors stop commercial vehicles for inspection purposes. Agriculture shipments and equipment are checked to verify that they meet specific quarantine requirements and are free of any guarantined pests and diseases.



The results of the road station inspections provide useful pest interception data for sharing with industry, the Legislature and other key stakeholders, so that we can better understand and study the risks posed by interstate commerce to agriculture, our health and the environment. Road stations are just another way TDA protects Texans across the state and Texas agriculture.

Appointments Announced for Texas Wine Industry Development Advisory Committee

The Texas Wine Industry Development Advisory Committee helps assess the condition of Texas' wine industry and develops recommendations for Commissioner Miller to assist in promoting and expanding the industry. The committee is a key component of TDA's efforts to administer the Wine Industry Development Fund and Texas Wine Marketing Assistance Program. In December, Commissioner Miller <u>announced</u> the lasted appointments to the committee.
